Attended state auction June 1, 2016. Three pieces of equipment were purchased: Grader - \$10,200, Gradall - \$6,700, manlift - 3,800. All are insured. Will attend a meeting with CCB Bank and also a pre-construction meeting with JD Northrup, Simmons Recovery, and Highway Superintendent to discuss FEMA project for Eldredge Road and Bailey Hill. Some reimbursements have been paid for completed FEMA projects. Union update concerning highway workers - no progress made between town lawyer and union representative. Equalization has been lowered to 92.5%. Assessor, Dennis Fisher is working on this issue.
